#### You'll act with integrity to:

- Be responsible for all matters with respect to the physical protection of the Legislative Precinct.
- Act in conformity with the law and established policies.
- Demonstrate a high degree of professionalism by exhibiting the utmost tact, diplomacy and confidentiality.
- Provide exceptional customer service in your daily interactions with Members of Provincial Parliament, the media, visiting dignitaries and the public.

#### You'll support our collaboration as you:

- Carry out your duties as a **Peace Officer** in accordance with legislation and Service standards.
- Apply the principles of bias-free law enforcement
- Conduct general patrols and control access within the Legislative Precinct
- Respond to calls for Service (i.e. criminal activity, security breaches, medical emergencies, potential threats, etc.)
- Maintain a safe environment in the Legislative Precinct by exercising police authorities, enforcing laws, and investigating.
- Prepare and submit timely and complete reports concerning investigations and Service activities.

### How You Qualify

#### You demonstrate excellence through your:

- At least 18 years of age.
- Minimum secondary school (high school) diploma.
- Post-secondary education is considered an asset.
- Possession of a Class G license;
- Fit for duty physical and mental ability to perform the duties of the position;

- A Canadian citizen or a permanent resident of Canada;
- Proficient in English, including written, oral, and reading.
- Successful completion of the 16-week Basic training program is required.

**Note:** While Canadian experience is not a requirement for the role, applicants with proof of a Canadian Police Service within the last four (4) years will be eligible to complete a basic training program of six (6) weeks if they can provide:

- Current or previous service with a Canadian Police Service within the last 4 years
- Proof of completing their probationary period with their current police service
- Proof of Accredited Police College Transcript
- Record of Discipline (formal and informal)
- Record of any on-duty motor vehicle collisions
- Record of Awards/Letters of commendation/appreciation
- Two letters of reference from Police Service
- Member in good standing with their Police Service including no outstanding, or previous disciplinary actions or charges.

Successful applicants who meet these experienced criteria will commence at the Step 3 rate.

You will be required to work rotational shifts, 40 hours per week in a 24-hour, seven-day-a-week operation.

**Note: The recruitment process includes successful completion of BPAD/PIN test on-site at Queen’s Park, Interview, Psychological Assessment, and an extensive background check, including a police reference check, will be required for those applicants who advance to the mandatory screening stage of our recruitment process. There is no parking available on-site at any point during the competition. Due to the high volume of applicants, please do not contact Human Resources for further information regarding the status of your application. Only those successful at each stage of the competition will be contacted.**

**Salary:** Employment offers are conditional on successfully completing and passing all training (academic and physical).
